3 BUG FIXES

3.1 Version 2.6.56_10 (change since 2.6.56_7)

- PT-2183: Gateway connection on ppp0 as secondary interface failed when eth0 cable is unplugged
- PT-2185: Gateway failed to connect to NS after config change though both ppp0 & eth0 are up
- PT-2188: Gateway lost default route after up and running with ppp0 and eth0 unplugged
- PT-2190: Fix applied.json/committed.json creation when file is missing

3.2 Version 2.6.56_7 (change since 2.6.56_4)

- PT-2132, PT-2134: Fixes to avoid and recover from empty /etc/network/interfaces

3.3 Version 2.6.56_4 (change since 2.6.56_3)

No bug fixes

3.4 Version 2.6.56_3 (change since 2.6.56_2)

- RDTP-17388: openssh command no longer tries to download autorevssh.txt file: autorevssh.txt has never been used, and it generates delays when openssh tries to download this file.
- RDTP-17879: ip_rule_set does not properly route traffic on unused interface subnet
- PT-1970: Gateway manager shall not wait for cellular interface when it is not activated
- PT-1969: Gateway manager shall not call reconfig_ppp twice
- PT-1971: Reset FPGA multiple time on LRR service start to fix radio start issue

- PT-1922: Fix special characters support in download/upload credentials

- PT-1918: NFR920 migration fix when ipsec.conf is empty

4 KNOWN ISSUES

- PT-1342: rfscanv1 failed with rfscan already running
- PT-1824: watchdog may reboot the gateway under heavy load
- PT-1818: syslogd stops after a while (may be due to ntpd restart)
- PT-1763: gateway doesn't support natively NTP synchronization via GPS.
- PT-1867: some class A downlinks may fail with cause a2 (time in the past)
